Fire equipment vendors invited to information sessions

Fredonia, Ariz., Dec. 8, 2016 — **For Immediate Release.** The USDA Forest Service Southwestern Region announces two information meetings for vendors interested in providing resources to support wildfires and other emergency incidents.

The first meeting is scheduled for Jan. 17, 2017, from 1:00 p.m. to 4:00 p.m. MST via video teleconference at Forest Service offices throughout Arizona. The first meeting will focus on Tents, Fuel Tenders, and Mechanics with Service Truck resources.

The second meeting is scheduled for Jan. 24, 2017, from 1:00 p.m. to 4:00 p.m. MST via video teleconference at Forest Service offices throughout Arizona. The second meeting will focus on Heavy Equipment resources.

The meetings will discuss a variety of topics including the following:

- How to become a government vendor
- How to locate and respond to solicitations through the Virtual Incident Procurement (VIPR) system
- How to read and understand contract requirements for specific equipment

For fiscal year 2017, the Southwestern Region is seeking competitive quotations for the following resources to support wildfires during the course of a three-year agreement:

- Heavy Equipment (dozers, excavators, and transports)
- Tents
- Fuel Tenders
- Mechanics with service trucks
